General:

Section 6 – Accidental Release Measures

6.1 Personal precautions

Ventilate the area thoroughly and shut off sources of ignition. Use protective equipment as described in Section 8. Avoid raising dust. Avoid breathing dust, vapours, mist, or gas. Floor may be slippery even when dry due to spherical beads.

Do not let product enter drains

6.3 Methods and materials for containment and cleaning up

Pick up and arrange disposal without creating dust. Sweep up and shovel. Keep in suitable, closed containers for disposal.

Section 7 – Handling and Storage

7.1 Precautions for safe handling

Provide appropriate exhaust ventilation at places where dust is formed. Do not tightly pack dry resin in glass containers. Dry resin will expand when exposed to solvents and failure to allow for expansion can cause glass containers to shatter. Avoid ingestion and inhalation. Avoid contact with skin and eyes

7.2 Conditions for safe storage

Keep container tightly closed in a dry and well – ventilated place. Store in a cool place, out of direct sunlight and away from incompatible substances

8.1 Personal protective equipment

Respiratory protection

Respiratory protection is not required when working with small amounts in a well – ventilated area. When working with larger amounts use type P99 (US) or type P3 (EU EN 143) dust masks. Use respirators and components tested and approved under appropriate government standards such as NIOSH (US) or CEN (EU)

Hand protection

Handle with gloves. The selected protective gloves have to satisfy the specifications of EU Directive 89 / 686 / EEC and the standard EN 374 derived from it. Gloves must be inspected prior to use. Use proper glove removal technique (without touching the outer surface of the glove) to avoid skin contact with product. Dispose of gloves after use in accordance with applicable regulations and good laboratory practice. Wash and dry hands

Eye protection

Safety glasses with side – shields conforming to EN 166. Use equipment for eye protection tested and approved under appropriate government standards such as NIOSH (US) or EN 166 (EU)
